CRCC has adopted a Code of Professional Ethics for Certified Rehabilitation Counselors (CRC) and Canadian Certificate Rehabilitation Advisors (CCRC). The standards of this mandatory code are intended to ensure that the profession of rehabilitation consultant assumes its responsibility to provide assistance to people with disabilities. All CRC/CCRCs are required to act according to the Code. Confidentiality of advisory relationships, Privilegiate Communication and the Adoption of Privacy and Accessibility Professional relationships of responsibility with other professionals and employers Forensic Services Assessment and Evaluation Supervision, Education and Teaching Research and Publication Technology, Social Media and Distance Consulting Business practices Solve ethical issues The ethics in the Public Services Act allows certain state employees to maintain gifts with an aggregate value of \$50 from a single source in a civil year or a single gift from multiple sources with a value of \$50. However, if you have been considered an employee "Section 4", this \$50 gift rule does not apply to you. Section 4 refers to paragraph 4 of the Ethical Law Regal Limitations section - RCW 42.52.150(4). This section imposes more stringent restrictions on gifts that can be received by officials and employees who are considered "Section 4" employees. To determine if you are an employee of Section 4, you have to ask yourself three questions: Question 1. Are you employed by a regulatory agency or agency looking to acquire goods or services? If yes, go to question 2. If not, then you wouldn't be considered an employee of Section 4. Question 2. Does your agency rule or contract with the person giving the gift? If yes, go to Question 3. If not, then it would not be considered an employee of Section 4 in this case. Question 3. Did you participate in the regulatory or contractual issues with that person? If yes, then you are considered an employee of Section 4 and would fall under the strictest rules regarding gifts found in RCW 42.52.150(4). If not, then you wouldn't be considered an employee of Section 4. Some agencies have designated their entire workforce as Section 4, so check with your agency. You can also be an employee Section 4 in one case and not in another. In case of doubt, you must consult your supervisor or contact the Ethical Council for advice. It is thebetween the organization and its public(s) before, during and after negative occurrence. Dialogue details strategies and tacticsminimise damage to the organization's image." The communication of the crisis is an emerging field in the applied communication studies and involves dealing with mediated messages and various types of audiences at times of increased pressure. Ethical issues are important considerations when a crisis occurs. In a crisis situation, business values that are important during normal and stability periods may not be so critical. For example, the normal emphasis on cost saving would no longer be appropriate when urgent measures are needed to save human lives in a natural disaster. Organizations have ethical responsibilities before, during and after a crisis. In the pre-crisis phase, the communication of crisis revolves around the monitoring of crisis risks, taking decisions on how to manage the potential crisis and training people who will be involved in the crisis management process. The communication of the crisis includes the collection and treatment of information for decision-making of the crisis team, along with the creation and dissemination of crisis messages. The emergency character of a crisis in the midst of great uncertainty already aggravates difficult decisionmaking with the urgency of making decisions quickly. Post-crisis communication involves assessing the crisis management effort and providing follow-up crisis messages if necessary.
