The 1 January of each year is the valuation date in Georgia. As a result, all properties must be valued for ad valorem taxes according to its terms and use as of 199.1. State law The state law provides that various homestead exemptions, which should be offered in each county, however some counties have implemented local legislation which increases the quantities of exemption within their jurisdictions. A farm demand can be made with the county of the tax office at any time during the year after the property becoming the primary residence, up to 1st April of the first year for which exemption is required. In some counties, the county tax commissioner accepts Homestead applications, and in others, the County Board of County of tax evaluators accepts applications.
